ORDER GRANTING BLANKET AUTHORIZATION TO IMPORT LIQUEFIED NATURAL GAS

DOE/FE ORDER NO. 2009

I. <u>DESCRIPTION OF REQUEST</u>

On July 30, 2004, BP Energy Company (BP Energy) filed an application with the Office of Fossil Energy of the Department of Energy (DOE), under section 3 of the Natural Gas Act (NGA), ^{1/2} for blanket authorization to import up to the equivalent of 1200 Bcf of liquefied natural gas (LNG) from various international sources. The authorization would be for a two-year term beginning on August 22, 2004. The applicant is a Delaware corporation with its principal place of business in Houston, Texas.

II. FINDING

The application has been evaluated to determine if the proposed import arrangement meets the public interest requirement of section 3 of the NGA, as amended by section 201 of the Energy Policy Act of 1992 (Pub. L. 102-486). Under section 3(c), the import of LNG is deemed to be consistent with the public interest and must be granted without modification or delay. The authorization sought by BP Energy to import LNG from various international sources meets the section 3(c) criterion and, therefore, is consistent with the public interest so long as the LNG sources are not subject to trading sanctions. This Order authorizes transactions under contracts with terms of no longer than two years.

ORDER

Pursuant to section 3 of the Natural Gas Act, it is ordered that:

- A. BP Energy Company (BP Energy) is authorized to import up to 1200 Bcf of liquefied natural gas (LNG). The term of the authority will begin August 22, 2004, and extend through August 21, 2006.
- B. This LNG may be imported at any LNG receiving facility in the United States and its territories.
- C. With respect to the LNG imports authorized by this Order, BP Energy shall file with the Office of Natural Gas & Petroleum Import & Export Activities, within 30 days following each calendar quarter, reports indicating whether imports of LNG have been made. Quarterly reports must be filed whether or not initial deliveries have begun. If LNG imports have not been made, a report of "no activity" for that calendar quarter must be filed. If imports have occurred, the report must give the details of each transaction: (1) the country of origin; (2) total monthly volumes in thousand cubic feet (Mcf) and million British thermal units (MMBtu); (3) the name of the seller(s); (4) the name of the purchaser(s); (5) the point(s) of entry; (6) the name(s) of the LNG tanker; (7) the estimated or actual duration of the agreement(s); (8) the geographic market(s) served (by State); (9) the average landed cost per MMBtu at the point of import; and, if applicable, (10) the per unit (MMBtu) demand/commodity/reservation charge breakdown of the contract price. The reports shall also include the monthly volumes in Mcf taken by each of BP Energy's customers. [OMB NO.: 1901-0294]

- D. The first quarterly report required by this Order is due not later than October 30, 2004, and should cover the period from August 22, 2004, until the end of the third calendar quarter, September 30, 2004.
- E. The reports required by this Order shall be filed with the U.S. Department of Energy, Office of Natural Gas & Petroleum Import & Export Activities, FE-34, P.O. Box 44375, Washington, D.C. 20026-4375.
